8. **Early Pay Off.** It is expressly understood by both parties that the resident may at any time pay the total amount due thereby satisfying this agreement in full. The \$49/semester processing fee will still apply.
9. **Rental Payment.** This agreement pertains only to rent and does not supersede any other terms set forth in the 2018–2019 Housing License.
